



BERMUDA END-TO-END 2026 GRANT APPLICATION

IMPORTANT GRANT APPLICATION INFORMATION

The Bermuda End-to-End (E2E) awards grants that fund non-sectarian Bermuda charitable programmes / projects that sustain and strengthen Bermudian families, the Bermuda Railway Trail and the wider Bermuda community. We support registered Bermuda charitable organisations that comply with the regulations set out in the Bermuda Charities Act 2014 and adhere to non-profit / charitable industry standards of accountability, governance and transparency.

The selected charities must be committed to assisting with all aspects of the E2E's fundraising efforts as requested. They must champion the support provided by the E2E throughout the lifetime of the grant on all their media platforms including social media, websites, print advertising and other forms of publicity.

Grant applications should be based upon either a \$10,000 or a \$50,000 allocation. Funding is typically distributed in July following the E2E Awards Reception. Grant recipients are required to complete and submit a Grantee Report by the end of January following the grant award.

Grant applications are accepted until Thursday October 30th at 5pm Bermuda time.

Online applications are not able to be saved so they must be completed in their entirety and submitted at the same time.

The application consists of twenty (20) questions and several pieces of supporting documentation. The questions and any applicable response constraints are shared on page 2. Please note the word limits on some of the answers. **We recommend you review the requirements prior to starting your application to ensure it can be completed in one sitting.**

Please ensure that you have fully completed the application and submitted all the documentation required. You will receive a copy of your application responses (excluding the attachments) once submitted. Final decisions on all applications are at the sole discretion of Bermuda E2E and **applicants can expect to receive funding decisions by December 1st.**

FREQUENTLY ASKED QUESTIONS

Q: Are there any programmes / projects that E2E will not consider when awarding grants?

A: E2E does not award grants to any of the following:

- Sectarian programmes / projects
- Endowment campaigns
- Travel for sports / school teams
- Support for schools or school trusts
- Funding deficits or previously incurred debts
- Programmes / projects that have already been completed
- Programmes / projects conducted outside of Bermuda

Q: Can I submit a hard copy application?

A: No, we only accept online applications.

Q: Can I save my application and come back to complete it at a later date?

A: No, the application cannot be saved.

Q: Will you make exceptions for late entries?

A: No, our 30 October 5pm deadline is final.

Q: What if there are essential materials for my application that are not available by the deadline?

A: All required materials must be included in your application.

Q: Can I include supporting materials not requested in the E2E grant application?

A: Please make your application without the inclusion of any additional materials.

Q: Can I refer to supporting materials for essential information on my application?

A: Please make your case for consideration on the application.

Q: When will notifications to grant recipients occur?

A: You should expect to hear from us by Dec 1st.
